Your Directors have pleasure in presenting the 32nd Annual Report on the affairs of the Company together with the Audited Financial Statements for the financial year ended on 31st March, 2026.

OPERATIONS AND PROSPECTS:

N G Industries Ltd. operates an integrated healthcare facility comprising Doctor Clinics, Outpatient Services, a Diagnostic Laboratory, an Indoor Facility with wards and ICU, Surgical Infrastructure, Dialysis Services, Special Clinics including Infertility, Retail Pharmacies, Home Care Services and an Adult Vaccination Unit. Dialysis Services were commenced during the year under review, extending the Company's indoor and specialised-care capabilities to patients requiring chronic and critical renal care.

The healthcare sector in India continues to be shaped by rapid technology adoption, wider insurance coverage, digitisation of patient records and changing patient expectations. Locally, Kolkata's healthcare landscape has seen ownership changes among some of the larger hospital groups, altering the competitive dynamics the Company operates within.

During the year under review, the global economic environment was significantly influenced by the conflict between Iran and the United States, which escalated tensions in the Middle East, a region central to global energy supply. This uncertainty pushed up international crude oil prices, and the resultant pressure on India's import bill contributed to a depreciation of the Indian Rupee against major currencies.

The combined effect of higher crude prices and a weaker Rupee fed through into a broader inflationary environment across the economy. Costs of transportation, fuel, and several categories of imported and import-linked goods rose in tandem, and this in turn placed

pressure on overall input costs for businesses across sectors. For the common citizen, this translated into a general increase in the cost of living, which, alongside stagnant wage growth in several segments, had the effect of reducing purchasing power, particularly for households at the lower and middle end of the income spectrum.

Reduced purchasing power among the masses typically has a dampening effect on discretionary spending, and healthcare — while largely a necessity-driven sector — is not entirely insulated from such pressures. The Company remains mindful of this environment while balancing the need to maintain quality of service against the imperative of keeping healthcare accessible and affordable.

Separately, West Bengal saw a change in its State Government following the Assembly elections during the year. Any resulting shifts in State health policy, insurance schemes, or regulatory approach are not yet clear at this stage, and the Company will engage with the new administration in the same constructive manner as it has with previous ones, adapting its operations as the policy direction becomes evident.

Sector trends we expect to shape the coming years include wider adoption of digital and AI-based diagnostic tools, continued expansion of cashless insurance networks, and a shift toward value-based and home-based care. The Company is positioning its systems and service mix to respond to these shifts as they take hold.

Operating performance for the year was muted, weighed down by input cost inflation and a competitive market, though the Company remained debt-free and continued its practice of consistent dividend payouts, interrupted only during the pandemic years. This financial discipline continues to underpin our ability to absorb external shocks without resort to borrowing.

Our approach to ethics and quality of care remains unchanged, and we record our appreciation of the clinical, administrative and support teams who deliver it. Going into FY 2026-27, priorities include strengthening our outpatient and diagnostic base, expanding preventive, digital-health and geriatric-care offerings, and deepening engagement with referring doctors and other stakeholders.

We consider the Company's performance for 2025-26 satisfactory given the operating environment described above, and expect a gradual return to stronger growth as conditions stabilise. We thank our shareholders, patients, employees and partners for their continued confidence in the Company.

There was no change in the nature of the business of the Company during the year, and there was no change in the composition of the Board of Directors.

DIVIDEND AND TRANSFER TO RESERVE:

The Board is pleased to recommend a dividend of ₹ 3.50 per Equity Share of ₹ 10 each (i.e. 35%) for the year ended March 31, 2026. The said dividend on equity shares is subject to the approval of the shareholders at the ensuing Annual General Meeting

("AGM") scheduled to be held on Saturday, September 26, 2026. Dividend will be paid after it is approved at the forthcoming Annual General Meeting. Also, the Board of Directors of the Company has decided not to transfer any amount to the Reserves for the year under review.

TRANSFER OF DIVIDEND AND CORRESPONDING EQUITY SHARES TO INVESTOR EDUCATION AND PROTECTION FUND:

In accordance with the provisions of Sections 124 and 125 of Companies Act, 2013 and Investor Education and Protection Fund (Accounting, Audit, Transfer and Refund) Rules, 2016 (IEPF Rules), dividends not encashed / claimed within seven years from the date of transfer to unpaid dividend account are to be transferred to the Investor Education and Protection Fund (IEPF) Authority.

The IEPF Rules mandate Companies to transfer shares of Members whose dividends remain unpaid / unclaimed for a continuous period of seven years to the demat account of IEPF Authority. The Members whose dividend / shares are transferred to the IEPF Authority can claim their shares / dividend from the Authority. In accordance with the said IEPF Rules and its amendments, the Company had sent notices to all the Shareholders whose shares were due to be transferred to the IEPF Authority and simultaneously published newspaper advertisements. List of such shareholders are also posted on the website (www.ngind.com) of the Company.

In terms of the provisions of Investor Education and Protection Fund (Accounting, Audit, Transfer and Refund) Rules, 2016, ₹ 33,541 of unpaid / unclaimed dividends and 552 shares were transferred during the financial year 2025-26 to the Investor Education and Protection Fund. The Company has uploaded the details of unpaid and unclaimed amounts lying with the Company as on 31st March, 2025 on the Company's website at www.ngind.com and on the website of the Ministry of Corporate Affairs at www.iepf.gov.in.

SHARE CAPITAL:

There is no change in the capital structure of the Company.

DISCOUNT TO SHAREHOLDERS:

The Company has decided to offer a discount of 15% to all shareholders of the Company on all the diagnostic services being offered by us. The shareholders availing the discount will be required to state their Folio number/DP ID and produce only identity documents.

MANAGEMENT DISCUSSION & ANALYSIS

This section sets out the Company's view of the industry environment, the principal opportunities and risks it faces, and its outlook for the year ahead.

INDUSTRY STRUCTURE & DEVELOPMENTS

Growth in India's healthcare sector continues to be driven by a combination of factors:

- Rising disposable incomes and a larger base of consumers willing to pay for quality care
- An ageing population with growing chronic-care needs
- Advances in diagnostic technology and AI-assisted tools
- Longer life expectancy, sustaining demand for preventive and long-term care
- Expanding public and private health insurance coverage

Union and State Government schemes continue to widen insured and subsidised healthcare access, with the stated long-term goal of near-universal coverage. Parallely, AI-assisted diagnostics, minimally invasive procedures, cloud-based records and telehealth are becoming standard features of service delivery rather than differentiators, raising the baseline expectation patients and referring doctors have of providers such as the Company.

Two developments outside the sector itself had a bearing on the operating environment this year. The Iran-US conflict drove up crude oil prices and weakened the Rupee, adding to input cost pressure across the economy, including on imported diagnostic and medical consumables. Separately, West Bengal's Assembly elections brought a change of State Government; the resulting policy direction on health insurance, regulation and public health programmes remains to be seen, and the Company will adapt as the picture becomes clearer.

LINGERING EFFECTS OF THE PANDEMIC

The pandemic's operational and financial effects on the Company have been covered in detail in earlier Annual Reports and in disclosures under "Information & Circulars for Shareholders" on our website, and are not repeated here. Its lasting effects are now largely confined to patient-interaction norms, infection-control protocols and staffing patterns that have become part of standard practice rather than an active area of disruption.

OPPORTUNITIES, THREATS, RISKS & CONCERNS

Opportunities:

- Rising insurance penetration, both cashless and reimbursement-based, is widening the addressable patient base.
- Digital and AI-enabled diagnostics offer scope for more efficient service delivery and better clinical outcomes.
- Growing demand for outpatient, preventive, home-care and vaccination services plays to the Company's existing strengths.
- The newly-commenced Dialysis Services open access to the chronic renal-care segment, an area of steadily rising demand.

Risks & Concerns:

- A slowing economy, particularly in services and informal sectors, can reduce discretionary spending on elective and non-urgent care.
- Reputational exposure remains inherent to healthcare delivery, where isolated adverse outcomes can attract disproportionate public attention regardless of clinical merit.
- Retaining experienced clinical and support staff continues to be competitive, given sustained demand for skilled healthcare talent.
- Referral relationships with independent doctors require ongoing investment to sustain, as patient and practice patterns keep evolving.
- Rising crude oil prices and Rupee depreciation, linked to the Iran-US conflict, have added to costs on imported equipment, diagnostic reagents/consumables and logistics fuel.
- A change in the West Bengal State Government following the recent Assembly elections may bring shifts in health-sector regulation, insurance schemes or public health programmes; the specifics are not yet known.
- Healthcare remains a politically and socially sensitive sector, periodically subject to regulatory or tariff-related interventions that can affect service economics.
- Litigation and, occasionally, public unrest directed at healthcare institutions remain an operational risk industry-wide.

The Company's principal mitigants against these risks include:

- Ethical, transparent dealings with patients, with realistic communication on treatment outcomes
- Ongoing staff training, clinical protocol adherence and periodic external quality audits
- Continued investment in diagnostic technology and equipment upgrades
- Efforts to retain skilled professionals through a supportive workplace environment
- Tracking input cost trends and exploring alternate vendor and sourcing options where practical
- Updated security and compliance measures, and open engagement with regulators and the new State administration

OUTLOOK

The Company's outlook for the year ahead is best described as cautiously steady. Demand fundamentals for healthcare services remain intact, but near-term cost pressures from global and domestic developments are likely to persist for some time. Against this backdrop, the

Company's priorities are to consolidate its diagnostic and outpatient base, build on the newly-added dialysis service line, expand its digital patient interface, and maintain the debt-free, dividend-paying track record that has characterised its governance to date.

CORPORATE GOVERNANCE :

I. Report on the Audit of the Financial Statements

1. Opinion

- A. We have audited the accompanying Standalone Financial Statements of N G Industries Limited ("the Company"), which comprise the Balance Sheet as at March 31, 2026, the Statement of Profit and Loss for the year ended on that date, cash flow statement as on 31st March, 2026 and a summary of the significant accounting policies and other explanatory informations (hereinafter referred to as "the Financial Statements").
- B. 2. Basis for Opinion

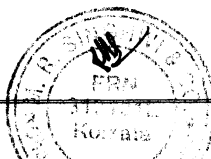

- B. Notes Forming Part of the Standalone Financial Statements for the year ended 31st March, 2026

1 Reporting Entity

"N G Industries Ltd" The Company has been incorporated under the provisions of Indian Companies Act 1956 on 17th November 1994 and engaged in Business of Healthcare through its divisions popularly known as N G Medicare & Calcutta Hope Infertility Clinic, N G Nursing Home and N G Pharmacy. The registered office of the Company is located at 1st Floor, 37A Dr Meghnad Saha Sarani, Kolkata 700029. The Company's equity shares are listed on the Bombay Stock Exchange (BSE) and Calcutta Stock Exchange Association (CSE) in India.

2 Basis of preparation of Financial Statements

(a) Basis of preparation and compliance with Ind AS

The financial statements of the Company have been prepared in accordance with Indian Accounting Standards (Ind AS) as per the Companies (Indian Accounting Standards) Rules, 2015 notified under Section 133 of Companies Act, 2013, (the 'Act') and other relevant provisions of the Act.

The standalone financial statements were authorised for issue by the Company's Board of Directors on 28th May 2026.

Details of the Company's accounting policies are included in Note 3.

(b) Functional and presentation currency

These Ind AS Financial Statements are prepared in Indian Rupee which is the Company's functional currency. All financial information presented in Rupees

(c) Basis of measurement

The Ind AS Financial Statements have been prepared on a going concern basis using historical cost convention and on an accrual method of accounting, except for certain financial assets and liabilities, including derivative financial instruments which have been measured at fair value and defined benefit plans which have been measured at actuarial valuation as required by relevant Ind ASs.

Unless otherwise stated all income and expenditure are accounted for on accrual basis.

(d) Measurement of fair values

Certain accounting policies and disclosures of the Company require the measurement of fair values, for both financial and non financial assets and liabilities.

The Company has an established control framework with respect to the measurement of fair values.

The valuation team regularly reviews significant unobservable inputs and valuation adjustments.

Fair values are categorised into different levels in a fair value hierarchy based on the inputs used in the valuation techniques as follows

- Level 1: quoted prices (unadjusted) in active markets for identical assets or liabilities.
- Level 2: inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly (i.e. as prices) or indirectly (i.e. derived from prices).
- Level 3: inputs for the asset or liability that are not based on observable market data (unobservable inputs).



When measuring the fair value of an asset or a liability, the Company uses observable market data as far as possible. If the inputs used to measure the fair value of an asset or a liability fall into a different levels of the fair value hierarchy, then the fair value measurement is categorised in its entirety in the same level of the fair value hierarchy as the lowest level input that is significant to the entire measurement

3 Significant accounting policies

The Company has applied following accounting policies to all periods presented in the Ind AS Financial Statement

(a) Revenue Recognition

Revenue (income) is recognised when no significant uncertainty as to determination/ realisation exists

Revenue from sale of goods and services rendered is recognized upon passage of title and rendering of services and, unless otherwise stated, is measured at the fair value of the consideration received or receivable inclusive of applicable taxes & duties

Interest Income is recognised on a time proportion basis taking into account the amount outstanding and the rate applicable.

Dividend Income is recognised when the Company's right to receive the payment is established, which is generally when shareholders approve the dividend.

(b) Property, Plant and Equipment

(i) Recognition and measurement :-

Items of property, plant and equipment, are measured at their original cost, net of Cenvat/GST, less accumulated depreciation. Additions include purchase cost, freight, duties and other expenses wherever incurred for acquisition and installation

Fixed Assets retired from active use are valued at net realisable value.

Gains and losses on disposal of an item of property, plant and equipment are determined by comparing the proceeds from disposal with the carrying amount of property, plant and equipment, and are recognized within other income/other expenses in statement of profit and loss

(ii) Subsequent expenditure :-

Subsequent expenditure is capitalised only if it is probable that the future economic benefits associated with the expenditure will flow to the Company

(iii) Transition to Ind AS :-

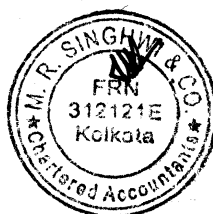
On transition to Ind AS, the Company has elected to continue with the carrying value of all of its property, plant and equipment recognised as on 1 April 2016, measured as per the previous GAAP, and use that carrying value as the deemed cost of such property, plant and equipment

(iv) Depreciation :-

Depreciation is calculated on cost of items of property, plant and equipment less their estimated residual value using straight-line method over estimated useful life, and in the manner specified in schedule II of the Companies Act, 2013. Depreciation is calculated on pro-rata basis on additions and deletions of fixed assets during the year.

(c) Investment property

Investment property is property held either to earn rental income or for capital appreciation or for both, but not for sale in the ordinary course of business, use in the production or supply of goods or services or for administrative purposes. Upon initial recognition, an investment property is measured at cost. Subsequent to initial recognition, investment property is measured at cost less accumulated depreciation and accumulated impairment losses, if any.



(d) Impairment of assets

An items of property, plant and equipment is treated as impaired when the carrying cost of asset exceeds its recoverable value. An impairment loss is charged to the Profit and Loss Statement in the year in which an asset is identified as impaired. The impairment loss recognised in a prior accounting period is reversed if there has been a change in the estimate of recoverable amount

(e) Inventories

Inventories of medical consumables, drugs, and stores and spares are valued at lower of cost or net realizable value. Cost is determined on weighted average basis. Net realizable value represents the estimated selling price in the ordinary course of business, less estimated costs of completion and estimated costs necessary to make the sale.

(f) Earnings per share

Earning per share is calculated by dividing the net profit or loss for the period attributable to equity shareholders, by the weighted average number of equity shares outstanding during the period.

For the purpose of calculating diluted earning per share, the net profit or loss for the period attributable to equity shareholders and the weighted average number of share outstanding during the period are adjusted for the effects of all diluted potential equity shares.

(g) Taxation

Tax expense comprises of current and deferred tax.

Current income-tax are measured at the amount expected to be paid to the tax authorities in accordance with the Indian Income Tax Act, 1961.

Provision for Income Tax comprises of current tax and deferred tax charge. Deferred tax is recognized subject to the consideration of Prudence, on timing differences, being difference between taxable and accounting income/expenditure that originate in one period and are capable of reversal in one or more subsequent periods

Minimum Alternative Tax (MAT) credit is recognized as an asset only when and to the extent there is convincing evidence that the company will pay normal income tax during the specified period. In the year in which the MAT credit becomes eligible to be recognized as an asset in accordance with the recommendations contained in guidance note issued by the Institute of Chartered Accountants of India

(h) Cash and cash equivalents

Cash and cash equivalent in the balance sheet comprise cash at banks and in hand and short-term deposits with an original maturity of three months or less, which are subject to an insignificant risk of changes in value. For the purpose of the statement of cash flows, cash and cash equivalents consist of cash and short-term deposits, as defined above.

(i) Borrowing Costs

Borrowing costs directly attributable to the acquisition, construction or production of an asset that necessarily takes a substantial period of time to get ready for its intended use or sale are capitalised as part of the cost of the asset. All other borrowing costs are expensed in the period in which they occur. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

(j) Cash Flow Statement

Cash flows are reported using indirect method as set out in Ind AS -7 "Statement of Cash Flows, whereby profit / (loss) before tax is adjusted for the effects of transactions of non-cash nature and any deferrals or accruals of past or future cash receipts or payments. The cash flows from operating, investing and financing activities of the Company are segregated based on the available information



(k) Use of Estimates and Judgements

The preparation of the financial statements in conformity with Ind AS requires management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income, expenses and disclosures of contingent assets and liabilities at the date of these financial statements and the reported amounts of revenues and expenses for the years presented. Actual results may differ from these estimates under different assumptions and conditions.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised and future periods affected

In particular, information about significant areas of estimation uncertainty and critical judgments in applying accounting policies that have the most significant effect on the amounts recognized in the financial statements are elaborated in notes.

(l) Segment Reporting

The Company is primarily engaged in the Business of healthcare services which is the only reportable business segment as per Ind AS 108 'Operating Segments'. Healthcare include various patient services delivered through Clinical establishments for Indoor Patient Services as well as Out Patient Services including Diagnostic services and Clinics with Pharmacy, Pathology and Radiology Services, Preventive Healthcare Services etc. The Company's business activity primarily falls within a single geographical segment.

(m) Provisions, contingent liabilities and Contingent Assets

Provisions are recognised when the Company has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation. When the Company expects some or all of a provision to be reimbursed, the expense relating to a provision is presented in the statement of profit and loss net of any reimbursement.

A contingent liability is a possible obligation that arises from past events whose existence will be confirmed by the occurrence or non-occurrence of one or more uncertain future events beyond the control of the Company or a present obligation that is not recognized because it is not probable that an outflow of resources will be required to settle the obligation. A contingent liability also arises in extremely rare cases where there is a liability that cannot be recognized because it cannot be measured reliably. The Company does not recognize a contingent liability but discloses its existence in the financial statements.

Contingent assets are neither recognised nor disclosed in the financial statements.

(n) Financial Instrument

Financial assets and financial liabilities are recognised when a Company becomes a party to the contractual provisions of the Instruments.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognised immediately in profit or loss.

All equity investments in scope of Ind AS 109 are measured at fair value. Equity instruments which are held for trading are classified as at FVTPL. For all other equity instruments, the Company decides to classify the same as at fair value through other comprehensive income (FVTOCI).

All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the marketplace.

All recognised financial assets are subsequently measured in their entirety fair value,



(o) **Employee benefits**

(i) **Short-term employee benefits :-**

All employee benefits falling due within twelve months of the end of the period in which the employees render the related services are classified as short term employee benefits, which include benefits like salaries, wages, short term compensated absences, performance incentives, etc. and are recognised as expenses in the period in which the employee renders the related service and measured accordingly.

(ii) **Post-employment benefits :**

Post employment benefit plans are classified into defined benefits plans and defined contribution plans as under :-

Gratuity :- The Company has an obligation towards gratuity, a defined benefit retirement plan covering eligible employees. The plan provides for a lump sum payment to vested employees at retirement, death while in employment or on termination of employment of an amount based on the respective employee's salary and the tenure of employment. The liability in respect of Gratuity, is recognised in the books of accounts based on actuarial valuation by an independent actuary. The gratuity liability for employees of the Company is funded with Life Insurance Corporation of India.

Provident Fund :- The Company makes contributions to statutory provident fund in accordance with Employees Provident Fund and Miscellaneous Provisions Act, 1952. Provident Fund is a defined benefit scheme the contribution of which is being deposited with Regional Provident Fund Commissioner. Company's contribution to the provident fund is charged to Statement of Profit and Loss.

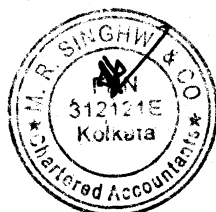

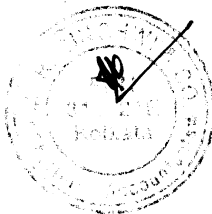

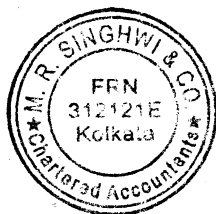
